On 8/20/12 at 2131 hours, I was dispatched to make phone contact in reference to a sexual assault. Upon making phone contact at the number provided, I came into contact with the victim identified as _____.

I asked _____ at _____ had happened to which _____ stated she had been raped on 8/20/12 at approximately 0015 hours in the morning. _____ stated she had an acquaintance over that night identified as Michael Dixon, in an attempt to get to know him better. _____ advised they had been sitting in her apartment for a while talking and trying to get to know each other better when Dixon asked if they could turn off the lights in the room they were in. _____ stated she had asked Dixon why he had wanted to turn off the lights. Dixon replied that his "eyes hurt." After _____ questioned Dixon, she stated she did not feel comfortable turning off the lights in the residence. Dixon replied to _____ she needed to "just chill." _____ advised that after a short while of arguing back and forth about why the lights should be turned on or off, she finally gave in and turned off the lights to the room in which they were in.

_____ advised me that prior to Dixon and her meeting that night, there had been text messages depicting there would be no sexual activity between them during this encounter. _____ went on to explain that after the lights had gone off they had went to her bed and laid there and she attempted to start talking to Dixon again in an attempt to once again get to know him better.

_____ advised that Dixon then leaned in and began to kiss her. _____ stated that when Dixon had kissed her, she had kissed him back. _____ stated the kissing lasted a while and then Dixon had stopped kissing her and had gotten on top of her. _____ stated she told Dixon she did not want to do this but that she just wanted to kiss him. I asked _____ what she meant by "this", to which she stated she did not want it to turn sexual. Dixon once again had advised _____ to "just chill out." While Dixon was telling _____ to "chill out", _____ advised that he was tugging at her pajama pants she had on. _____ stated she was holding the pajama pants up for a short while but then Dixon was able to get them off of her. _____ stated she was not comfortable with her pants coming off and that she had told Dixon multiple times to stop and that she did not want to have sex with Dixon, to which Dixon told _____ once again to "just chill out."

_____ advised after Dixon had told her to "chill out", she had attempted to push him off of her using her arms to no avail. I asked _____ if Dixon had held himself on top of her by grabbing her or if he had held her down. _____ stated that Dixon did not do either of these actions, but that she was unable to lift him up off of herself. _____ stated she had told Dixon after her attempt to get him off, that "no you don't even have protection, this is disgusting." After _____ had said this, she advised that Dixon had reached into his pocket and pulled a condom out. _____ explained that Dixon had unwrapped the condom and placed the condom upon himself.

[redacted] advised that a short while afterwards, Dixon had penetrated her with his penis. [redacted] stated that upon his penetration of her, she was in a considerable amount of pain and was unable to move. [redacted] advised that Dixon had continued to penetrate her and after a short while he had asked [redacted] to turn around. [redacted] advised she had listened to Dixon and turned around to facilitate Dixon's penetration of her from behind. I asked [redacted] approximately how long this has lasted. [redacted] advised it was approximately 20 minutes, in her perspective. I asked [redacted] if she had ever tried to stop Dixon while he was penetrating her. [redacted] advised she had just let it happen and she did not know why. I asked [redacted] if she was afraid of what might happen if she refused to do what Dixon had asked. [redacted] stated she was not afraid of being struck or any physical contact from Dixon that might harm her other than what was happening at that moment.

After Dixon was done, approximately 20 minutes, [redacted] advised me Dixon stopped and she attempted to grab her pajama pants and place them back upon herself. [redacted] stated that while she was reaching for the pajama pants, Dixon looked at her and stated, "what the fuck are you doing?" [redacted] stated she replied to Dixon, "I'm putting my pants on because this was never supposed to happen in the first place." [redacted] stated Dixon had once again told her to "just chill out." [redacted] advised she was finally able to get her pants off the floor where Dixon had thrown them and proceeded to go to the bathroom. Upon [redacted] return, she advised Dixon had asked her to perform oral sex on him. [redacted] stated she told Dixon no and that she was not going to do that. [redacted] stated she then went back on the bed where Dixon was laying, and he had asked her then to masturbate him. [redacted] stated she does not know why she did, but she then proceeded to masturbate Dixon to where it is believed he ejaculated. [redacted] advised that after Dixon was finished he had got up and got dressed and then exited the residence, leaving in a light blue vehicle which is believed to be owned by him.

I asked [redacted] if she had gone to the hospital and had a sexual assault kit done. [redacted] advised she had not gone to the hospital yet. I advised [redacted] that in order to further our investigation into this case, it would be helpful if she went to the University of Missouri ER and had the kit done. [redacted] stated she would call a friend and go down to the University ER to get this kit done. I asked [redacted] if she still had the bed sheets as well as the clothing she was wearing or any underwear she had worn after the encounter, to which she stated yes. I advised [redacted] I would be coming to her residence to collect these for evidence in reference to the case. [redacted] stated she would wait for my arrival to her residence.

Upon my arrival at [redacted] I met [redacted] and collected the pajama pants in which she was wearing underwear, which she had

put on afterwards a red rag, which she stated was used by Dixon to "wipe himself" after his ejaculation, the shirt she was wearing during intercourse, as well as the bed sheets she was laying upon during the encounter. I kept these items in my care and custody until my return to the Columbia Police Department where they were entered into Evidence and submitted to the Missouri Highway Patrol for DNA testing.

On 08/20/2012 at 2245 hours, I was advised by Sergeant Jason Jones of a Rape-forcible investigation reported by [redacted] reported to Officer Williamson of being sexually assaulted on the early morning of 08/20/2012 by Michael Dixon at [redacted] For reference, see case number #2012-009670 and supplemental case number #2012-009670/1.

Sgt. Jones told me [redacted] was have a SAFE examination at University of Missouri Hospital and Clinics, #1 Hospital Drive, and agreed to respond to the Columbia Police Department afterwards to give a statement to me. I then responded to the Columbia Police Department to meet with [redacted]

At 0141 hours, I responded to University Hospital and Clinics to check on [redacted] welfare. When I arrived, I was told [redacted] left the clinic, several minutes prior to my arrival.

On 08/21/2012 at 0824 hours, I attempted to contact [redacted], via telephone. I left a message on [redacted] voice mail, requesting her to contact me. At 1349 hours, I received a voice mailbox message from [redacted]. [redacted] told me she was in class when I called earlier, and she was now out of class and available to be contacted.

At 1351 hours, I called [redacted] and spoke with her. [redacted] agreed to

give me a statement at the Columbia Police Department, and I asked her if she needed travel arrangements. said her roommate was still in class, and I asked her if she would like me to give her a ride to the Columbia Police Department. said that was fine. At 1443 hours, and I entered Major Crimes Interview Room #2 and sat down. confirmed the spelling of her first and last name, and said she is a Sophomore student at the University of Missouri. Prior to the interview, I asked if she had any questions for me. said she did not.

I asked to tell me what happened, in detail, on the day of the occurrence. stated on 08/20/2012 at approximately 0040 hours, Mr. Dixon came over to her apartment. said they are not on dating terms, and they just wanted to get to know each other. Mr. Dixon entered bedroom, and he sat down on the bed. closed the door (to the bedroom), and sat on the bed with Mr. Dixon. and Mr. Dixon were talking for approximately two minutes, and they were sitting up on the bed during that time. asked Mr. Dixon how Paris was, and they talked about basketball together. also asked Mr. Dixon about games, and he answered by using one word answers. said it was silent for a little while, and Mr. Dixon asked her to cut off (turn off) the lights. asked Mr. Dixon why, and he told her his eyes hurt from the light. Mr. Dixon kept asking to turn the lights off, and told me the lights in her bedroom were dim. was getting annoyed because Mr. Dixon kept asking her to cut the lights (turn the lights off), and she told him he knew they were not going to do anything right (meaning sex)? Mr. Dixon would tell her to, "just chill."

then told me about when she and Mr. Dixon tried to date in the past semester. Mr. Dixon would try to come over late in the evening to have sex, and would say no.

I asked to tell me what happened next. turned off the lights, went back to the bed and sat down. It was silent. asked Mr. Dixon a question she could not remember, and he leaned over and kissed on the lips. said she was fine with that, and she was leaning down on the bed, on her left side. Mr. Dixon was leaning down on the bed, on his right side. After they started kissing, Mr. Dixon got on top of her. was laying down on her back on the bed, and Mr. Dixon was positioned over her. While they were kissing, remembered her hands were on his arms, and Mr. Dixon's hands were on the bed beside her.

After and Mr. Dixon were kissing and touching, Mr. Dixon got up and started tugging on her pajama bottoms. said she was wearing pajama bottoms with no underwear. leaned forward on the bed, and she was pulling up on her pajama bottoms. asked Mr. Dixon what he was doing, and Mr. Dixon was telling her to, "relax and just chill out." told Mr. Dixon she was relaxed, didn't want to have sex and do anything. Mr. Dixon grabbed her pajama bottoms at the waist, and took them off with one motion.

Mr. Dixon threw the pajama bottoms on the floor. went to the left side of the bed to look for the pajama bottoms. Mr. Dixon was still on the bed, laying close to the middle. While was looking for her pajama bottoms on the left side of the bed, Mr. Dixon removed his shirt. then went back to the middle of the bed, and began going to the right side of the bed to look for her pajama bottoms. At this time, Mr. Dixon got on top of her. said her arms were folded on her chest, and she was trying to push up on Mr. Dixon's chest with her arms and hands. also said she was turning her face away from him. Mr. Dixon's pants were down halfway, and he was trying to force himself inside her. Mr. Dixon was trying to force himself inside her by trying to push his penis inside her vagina to have sex. I asked if he had an erection, and she said he did.

At this point of the interview, began to cry. said it hurt, and she told Mr. Dixon to get off of her. She told Mr. Dixon he did not have a condom and he was disgusting. was referring to Mr. Dixon having sex with other females without using a condom. Mr. Dixon reached inside his pants pocket, and he took out a yellow and white packaged Trojan condom. said she was still annoyed, and tried to lighten the mood by telling Mr. Dixon there was no need to get a condom because they were not going to have sex. Mr. Dixon opened the condom and rolled it on his penis. After Mr. Dixon put the condom on, he was still on top of by laying directly on top of her. said it was very difficult for her to push him off. When kept pushing him, she told him no again. Mr. Dixon then forced his penis inside of her, and that lasted for approximately 15- 20 minutes. again began to cry, and told me she invited him over because she was bored.

Mr. Dixon put his penis inside her vagina. said while this was going on, Mr. Dixon paused. got off the bed. was pissed, and yelling, at Mr. Dixon. Mr. Dixon was yelling at about what she was doing, and to get back on the bed. yelled back at Mr. Dixon that she didn't want to have sex with him because he

got off the bed, and put on her pajama bottoms in front of the bathroom door. Mr. Dixon was standing up by the end of the bed. Mr. Dixon was still undressed, with the exception of wearing socks. Mr. Dixon took by the hand, and he led her to the bed. When and Mr. Dixon were both on the bed, he asked to "jack him off," and she did. I asked to tell me what "jacking off" was. said she had her hand on his penis, and she was moving her hand up and down. said while she was "jacking off" Mr. Dixon, he asked her repeatedly for oral sex. said no. Mr. Dixon asked her approximately two- three more times for oral sex, and she said not to him every time he asked. Mr. Dixon ejaculated, and he asked for a towel. gave him a small towel, and he used the towel to clean himself with.

stopped, got off the bed, and he got off the bed. Mr. Dixon took off the condom he was wearing, and put it on the floor. threw Mr. Dixon his shirt, and he put on his shirt. While Mr. Dixon was doing so, she turned on the light to the bedroom. Mr. Dixon put on his boxers and pants. After he finished dressing, she walked him from the bedroom to the front door. opened the door for Mr. Dixon, and he left.

I asked of Officer Williamson recovered the towel. She said he did. I asked if Officer Williamson recovered the condom. said he did not. I asked her where the condom was. said she threw the condom away in the trashcan in the kitchen. I asked to tell me what clothing she was wearing. said she was wearing a shirt and bra, and those items of clothing were never taken off. I asked if Mr. Dixon every tried to take off her shirt and bra, and she said he did not. I asked to tell me what Mr. Dixon was wearing. Mr. Dixon was wearing dark green camouflage shorts that went below the knees, white socks, black Air Jordan sandals, hat with red, and a gray/red/white "Old Bay" logo t-shirt and watch.

I asked if she and Mr. Dixon have spoke since this happened. She said they had not spoken since this happened. said she sent him a text message, but deleted it because she did not think she was going to report it. I asked how she and Mr. Dixon met. and Mr. Dixon met at a Farmhouse fraternity house party during St. Patrick's Day weekend of 2012. was dancing on him. entered her telephone number into Mr. Dixon's cellular telephone. described their relationship as annoying, because Mr. Dixon would stand her up, and she was always wanting to see him and spend time with him. Mr. Dixon was always busy, or he wanted to come over late at night. Mr. Dixon would call around 0002-0003 hours while she was living at the dormitory, and he would ask her if her roommate was there and if he could come over. believes Mr. Dixon wanted to have sex. I asked if she and Mr. Dixon have had a sexual relationship. She said they did not have a sexual relationship, and the last conversation they had was Mr. Dixon telling her he wanted to have sex with her.

I asked why Mr. Dixon came over to the apartment. Mr. Dixon got back from Paris on the day before the offense, and he sent a text message saying, "what's up". responded back, and Mr. Dixon asked her what she was doing. told Mr. Dixon she was originally going to a party, but later changed her mind and said she was going out. told Mr. Dixon he couldn't come over Saturday night (08/19/2012), and didn't want Mr. Dixon to see her, or be around her when she was like that (being drunk). Mr. Dixon sent a text message, saying he was going to be drinking too. Mr. Dixon also texted it would be good if he didn't see her because he would want to have sex with her. On the morning of 08/20/2012, Mr. Dixon called her, and also sent her a text message saying, "what's up". later responded back to a text message at 1130 hours (several hours after receiving the text message), and Mr. Dixon did not respond back. alled Mr. Dixon after sending the text message, and they had a friendly conversation. asked Mr. Dixon if she could see him today, and he said later and agreed to see her at 2000 hours. told him that was fine. I asked if there was any other contact between her and Mr. Dixon between 1130 hours and 0040 hours. She said there was not. said Mr. Dixon called her a 0040

[redacted] said they went to the bedroom because her roommates were asleep, and their rooms are outside the living room. [redacted] did not want to disturb her roommates, and there was no furniture on the back patio to sit on.

I asked [redacted] what she wanted the Columbia Police Department to do for her. [redacted] said she did not know. I asked [redacted] if she wanted to prosecute. [redacted] said she doesn't think she really said a lot, and just said "no." Mr. Dixon was telling her to "relax" and "chill" repeatedly.

[redacted] said Mr. Dixon was laying flat on the bed, and she was laying down on her left side, with her head leaning off of the bed. Mr. Dixon was moaning, and that is when he asked her to perform oral sex on him. I asked [redacted]

At 1703 hours, released her HTC Desire cellular telephone to me. I released the cellular telephone to Detective Rukstad to perform the download. I asked who her roommates were. said her roommates were (unknown last name), and

At 1712 hours. Detective McLane and I drove back to her residence at While we were driving to the residence, I asked when she threw out her kitchen trash. She said she threw out the trash on the morning of 08/21/2012. I asked if she could show me which dumpster she threw the trash away at, and she did so when we arrived to the apartment complex. The dumpster was located in the parking lot, west of I asked to show me the area of the dumpster where she threw away the trash. walked to the northeast corner of the dumpster, and said she threw the trash up on top. was able to identify a box she threw away, along with the trash.
